- **AI in Healthcare Focused by PGI Authorities:** Sanjay Gandhi Post Graduate Institute of Medical Sciences governing body emphasized advancing specialized healthcare and integrating artificial intelligence tools into clinical practice.
- **India-Afghanistan Health Group Talks:** India and Afghanistan discussed forming a *joint working group on health* to collaborate on healthcare development and facilities, including cancer care.
- **PIL to Classify Air Purifiers as Medical Devices:** A plea in the Delhi High Court argues air purifiers should be categorized as medical devices to reduce GST from 18% to 5%, citing health needs amid pollution concerns.
- **Court Blocks Medical Council Credit Withholding:** A Kolkata court restrained the West Bengal Medical Council from withholding continuing medical education credit points from doctors.
